## FROM OUR PASTOR, REV. KAREN HANDY

Who would have ever thought! When 2020 began, we looked ahead to a year filled with hope. Little did we know what was ahead of us.

Today, we are living in the midst of a strange and peculiar time. We have “Stay Home” orders. (I could have used a few days of that, but now it is getting longer and longer.) We wear masks that hide much of our face. We have jobs that have been determined as “essential” and “non-essential.” To top it all off, our school buildings will remain closed and virtual learning will continue through the end of the school year. A year filled with hope has turned to one that feels odd, and for some, full of fear.

This reminds me of a

story in the Bible. It can be found in Matthew 14:22-36. The disciples had just witnessed the miracle of Jesus feeding 5,000 with five loaves of bread and two fish. (Sounds like a great start of something.) He sent the disciples to cross the lake at night while he stayed to pray. During the night, a storm came up with great winds. The calm sea now had heavy and high waves. (This was scary!) Jesus came walking out on the water to the disciples. Peter asked to be able to walk on the water like Jesus. He does get out of the boat. He walked a little ways, but then remembered and saw the giant swells. He started to sink and cried out and Jesus reached out to him.

There are a couple of things that might help us during the COVID-19

crisis. First, Jesus did not first calm the storm, but came to his disciples in the storm. God knows what you are experiencing and He is right there with you in the midst of it! Second, keep your eyes on Jesus. Peter didn't begin to sink until he took his eyes off of Jesus.

When Peter and Jesus got back in the boat, the storm subsided. This storm and crisis will subside as well. If we learn to trust Jesus by keeping our eyes on him and realizing he is with us even in our storms, this may still be the year filled with hope to which we looked forward. We may find in this storm, our greatest hope is in Jesus.



## St Luke's UMC COVID-19 Phase 1 (Low-Risk) Re-Opening Plan

The “Stay Home” order from the Governor as a response to COVID-19 has been unprecedented. It has impacted all aspects of our day-to-day living, including participating in the worshipping community. St. Luke's has sought to care for our neighbors by taking a conservative approach to encourage social distancing in order to limit the spread of the virus in accordance with guidelines from the State of Maryland. On May 13, 2020, Governor Hogan announced that we would begin the “Roadmap to Recovery” on Friday, May 15, 2020 at 5pm. Utilizing both the “Roadmap to Recovery” and a document provided by a Faith-Based group that worked with the Governor and his team on how to re-open churches, St. Luke's has laid out some of the following guidelines in order to resume worship when it is appropriate. Please understand that this is a plan and it will be adjusted, changed, or refined as we live into the orders and suggestions of the State and Federal Government. We have done our best to think through various expected situations, but as we all know this is a strange time. We appreciate your patience as we work together.

Our Sexton, Denny Weaver, has been working hard to disinfect and deep clean the various rooms throughout the building.

### **Phase One (Low-Risk): Worship can Resume at 50% Capacity**

While the “Stay Home” order will be lifted in this phase, we are given an option of outdoor worship or in our facility at 50% capacity. Therefore, we will begin worship at a 50% capacity in our facility on Sunday, May 24, 2020. Our leadership believes that we will be able to gather with social distancing guidelines adapted for worship. Those who are most vulnerable to COVID-19 will be encouraged to stay at home and utilize the online worship services through Facebook and the church website ([www.stlukesdenton.org/sermons](http://www.stlukesdenton.org/sermons)). Access to the online worship service will be St. Luke's Facebook page and the church website ([www.stlukesdenton.org/sermons](http://www.stlukesdenton.org/sermons)) and available at 10am each Sunday.

### **We will resume our regular worship times with some strict guidelines in place.**

We ask that each person planning to attend worship self-check their temperature at home prior to arriving. If your temperature is elevated, please remain home and utilize our online worship option. Worshippers are also required to wear a mask while in the building.

### The 8:30am and 11am Service worship in the Sanctuary:

**Entry:** Please enter the building at the opened door which will be closest to the sanctuary on the back side of the church facing the Armory. (The entrance facing 5<sup>th</sup> Avenue will not be open.) We will offer signage to help you with your entry. You will enter the Sanctuary at the single door which will also be open for you.

**Seating:** Seating will take place in every other pew. (Pews will be taped off to help us maintain this and we ask that you only sit in the pews that are open.) Family Household Units may sit together and we will ask non-household units to keep a minimum of seven feet between your neighbors. (Consider sitting on the pew ends only which will give the at least 7 feet required between persons or family units).

**Exiting the Worship Service:** We will dismiss by pew and through the chapel.

### The 9:40am (Ignite) Service:

**Entry:** You are asked to enter the building at the open door closest to the church office. We will offer signage to help you with your entry.

**Seating:** We will resume meeting inside the Fellowship Hall. Seating will be in chairs (no tables will be set up at this phase) that are set 7 feet apart. Family Household Units will be allowed to sit together.

**Exiting the Worship Service:** There will be a dismissal process that will be given at the end of the service.

There will be a strict “no-touch” policy during worship, which would eliminate the “Passing of the Peace” during worship. You are encouraged to consider giving your offering and gifts to the church via online giving, through your bank, or mailing. There will be baskets or boxes at the exits of the Sanctuary and Fellowship Hall for those who do bring an offering (no formal offering will be done during the service). Communion will be served in pre-packaged communion cups to limit contact. **No food will be offered including coffee or water during this phase.** You can bring your own coffee however!

Bulletins and handouts will not be produced during this phase. We have also been asked to refrain from corporate singing. This means that we will still offer music at each service, but participants will be asked to not sing even with a mask in place.

Hymnals and Bibles will be removed from the Sanctuary during this phase. Scripture will be shared and a message will be delivered during each service.

Greeters and Ushers will be asked to refrain from shaking hands as parishioners enter and exit the building. The worship space and public areas will be thoroughly cleaned and sanitized during the week. Doors will be propped open to prevent multiple people touching the same door.

**There will be no activities at the church other than Sunday morning worship services.**

Meetings and Bible Studies will continue to be canceled at the church unless they take place virtually through Zoom.

### Other Possibilities:

**Outdoor Worship Opportunities-** We have not utilized drive-in style worship, mostly because of appearances and lacking a space large enough to fit the cars that would be involved as well as cost for a FM Transmitter that will cover the size of our parking lot. However, as we enter Phase Two, there may be opportunities to gather in-person for worship or fellowship depending on the setting.

**Easter Celebration-** Let's face it, Easter was different this year. We would all have preferred to worship in person. Because every Sunday is resurrection Sunday, we will be scheduling an "Easter Celebration" later in the year when it is appropriate.

### Bulleted Version of the Plan

#### Phase One: Physical Gathering at 50% Capacity Under Strict Guidelines

- Worship held at normally scheduled times
- Seating will be in every other pew or chairs
- Maintain seven feet of distance between household unit
- Masks required to be worn during worship
- Strict "no-contact" during worship
- No longer "Pass the Peace" during worship
- Singing is prohibited during this phase by participants and only a group of 5 or less with appropriate social distancing is permitted to offer a special song or music
- Offering is encouraged to be given via online giving, through your bank, or mail a check. Those giving in person will utilize baskets at the exit of each worship space

- Coffee and refreshments will not be served during this time (But bring your own!)
- Communion will be celebrated using the pre-packaged wafer and cup. It will be distributed by those wearing masks and gloves. Communion will not be served during the month of May
- Services will last 45 minutes or less to create more space in between gatherings
- Hand Sanitizer and Clorox wipes (as available) on-hand
- Make every effort to clean and disinfect the Sanctuary and public spaces after worship
- No Sunday School, small groups, meetings, or Nursery Care during this time
